- (2) A declaration that under section 3 of DRIPA, consistency between any law of British Columbia and UNDRIP is justiciable; the Provincial Crown's system for granting mineral titles through the combined operation of the *Mineral Tenure Act*, RSBC 1996, c 292, the *Mineral Tenure Act Regulation*, BC Reg 529/2004, and the Mineral Titles Online Registry, taken together (the "Mineral Grant Regime"), is not consistent with UNDRIP; and the Provincial Crown has a statutory duty to consult and cooperate with Gitxaała concerning measures necessary to ensure the Mineral Grant Regime is consistent with UNDRIP.
- (3) An order quashing the mineral claims challenged by the petitioners held at the time of judgment of the Supreme Court by Christopher Ryan Paul and Oliver John Friesen.
- (4) An order enjoining the Chief Gold Commissioner from allowing for registration of any mineral claim, without prior consultation with Gitxaała, over the lands over which Gitxaała has asserted aboriginal title (the "Title Lands").
